#### ADMINISTRATIVE EXPERIENCES AND RESPONSIBILITIES

April 2020-present Dean, College of Natural Resources, North Carolina State University

The Dean of College of Natural Resources (CNR) at NC State University reports to the Provost and Executive Vice Chancellor. The College includes three academic departments (Department of Forestry and Environmental Resources, Department of Forest Biomaterials, and the Department of Parks, Recreation and Tourism Management) and an interdisciplinary center (Center for Geospatial Analytics) with approximately 70 faculty and over 250 professional and technical staff. Total enrollment within CNR is approximately 1,600 undergraduate students and over 400 master's and Ph.D. students. The College offers 10 bachelor's degrees, 10 master's degrees, four distance master's degrees and four doctoral programs. The total budget for FY2022 was \$45.7 million. This includes \$18.2 million in state academic appropriations and \$11.6 million in grants and contracts. The total college portfolio of active sponsored research was approximately \$60 million. CNR has the second largest McIntire-Stennis research program in the U.S (\$1.1 million). The College maintains a diverse land base of forest and wetland areas totaling 93,880 acres for teaching and research, including the 79,000-acre Hofmann Forest. The Dean provides strategic leadership for the College and represents the College to internal and external stakeholders and constituents.

2014-2019 Department Head, Department of Parks, Recreation and Tourism Management, North Carolina State University

As Head of the Department of Parks, Recreation and Tourism Management, Dr. Floyd led a vibrant community of approximately 600 undergraduate students, over 125 master's and Ph.D. students, 10 professional and administrative staff, and 26 full-time faculty. The undergraduate program encompassed three majors: B.S. in Parks, Recreation and Tourism, the B.S. in Sport Management, and the B.S. in Professional Golf Management. At the graduate level, the department offered the Master of Park, Recreation, Tourism and Sport Management (online), the MS and Ph.D. in Parks, Recreation and Tourism Management. The Department co-administered the Master of Geospatial Information Sciences and Technology with the Department of Forestry and Environmental Resources. In addition to academic degree programs, Dr. Floyd provided leadership for the department's Cooperative Extension program (Tourism Extension),

Recreation Resources Service (a technical assistance program funded by NC Department of Natural and Cultural Resources), and continuing education programs held at the Oglebay National Training Center in Wheeling, WV. The department budget exceeded \$2.5 million.

As Director of Graduate Programs (DGP), and working closely with the Department Head, Dr. Floyd provided critical oversight for graduate education and research within the department. As DGP, Dr. Floyd's major responsibilities were correspondence between the department and the Graduate School, recruitment and admissions, approving students' plans of study, monitoring graduate students' progress toward graduation, assignment of departmental assistantships, assignment of office space, setting policies, nominating students for fellowships and awards, coordinating graduate students' defenses and final examinations, and coordinating annual assessments and periodic program reviews.

Director, Center for Tourism Research and Development (CTRD), Department of Recreation, Parks and Tourism, College of Health and Human Performance, University of Florida.

As Director for the CTRD, Dr. Floyd coordinated research studies to support local and statewide destination management organizations. This included identifying requests for proposals, meeting with local and state level organizations, and recommending proposals to the department head for internal funding.

# PRT 350 Outdoor Recreation Management (2005)

This 3-credit course explored concepts and methods of outdoor recreation planning and management, with emphasis on public lands. Students examined environmental and social impacts of visitor use of recreation resources and management strategies that promote quality visitor experiences and resource protection.

### PRT 380 Evaluation and Analysis (2005-2010)

Using lecture and lab assignments, this 3-credit course examined systematic approaches for evaluating and estimating the impact of recreation and parks services.

# PRT 351 Outdoor Recreation Consortium (2019)

This 3-credit course provided students with hands-on exposure to the multifaceted nature of national park management and awareness of the complex challenges facing park managers. The course culminated with a week-long trip to the Great Smoky Mountains National Park along with students and faculty from East Carolina University, Penn State University, Texas A&M, University of Missouri-Columbia, and Western Illinois University.

# PRT 504 Data Management and Applications in Parks, Recreation, Tourism and Sport

This online course for master's students introduced research and evaluation procedures and techniques used to solve management problems. The course provided an overview of techniques for data collection, data management, analysis, and communicating research findings.
