- We have three new faculty hires in the college. Dr. Rajan Parajuli, Extension Assistant Professor, forest economics, FER; Dr. Frederik Laleicke, Extension

Assistant Professor, wood products, FB; and Dr. Jack Wang, Assistant Professor, molecular genetics in FER.

Dr. Thomas Easley, Director of Diversity, resigned from our college to accept a
position at another institution. We are collecting information from a variety of sources
and institutions on diversity and inclusion and will be moving forward with filling our
vacancy in the next few months.

Lara Brown de Fuenmayor gave an update on our capital campaign as of December 31. The College has raised \$24.4M toward its goal of \$35M.
